and

Department of Information Science and Engineering, HKBK College of Engineering, affiliated by AICTE with registered address, No.22/1, Opposite, Manyata Tech Park Rd, Vyalikaval Society, HBCS Layout, Nagawara, Bengaluru - 560045, Karnataka. Here in referred as "HKBK".

Purpose of MoU

The MoU is being signed by both the parties to build knowledge and innovation ecosystem between the TechCiti Technologies Private Limited and HKBK College of Engineering to meet the market demand in a software skill development by providing internship opportunities to students of HKBK college of engineering

As part of this MoU, both the parties hereto agree to the following respectively:

Obligations of Techciti:

1. TechCiti will be providing internship opportunities in area of software development, with the aim of skill development of the students, thus enhancing their employability skill.
2. The selection of the students for the internship program will as per the guidelines of TechCiti.

Obligation of HKBK College of Engineering:

1. HKBK, shall be responsible to update TechCiti on the availability of the students for the internship program.





Miscellaneous:

1. This MOU supersedes all prior oral or written communication, discussions and representations communicated between the parties hereto in respect of the subject matter of this MOU. Any modification to this MOU shall only be made by way of a written document duly executed by representatives of both parties hereto.
2. Both parties will appoint a POC (point of contact) to handle communications and initiatives under this MOU.
3. Any disputes that may arise in the implementation of this MoU will be resolved through discussions between POC (Point of Contact) of both parties.
4. Any Party will not have rights to use intellectual properties and branding assets of other Party unless prior permission has been sought from the other party.

Term and Termination:

1. This MOU will lapse if there is no activity or engagement between both the parties for a continuous period of 12 months from the start of the agreement date.

2. 1 year from the date of signing, this MOU is at-will and may be modified by both parties through a written notification from authorised officials from each party. This MOU shall become effective upon signature by the authorised officials and will remain in effect until modified or terminated by any one of the parties through a written notification or the end of term of the MOU is reached.
